Initial Holding Deposit (Payable to reserve a Plot & Home) 150,000 THB*** (All deposit paid to Sanctuario Properties Co., Ltd. are Non-Refundable unless specified in writing by us.)

FIRST STAGE PAYMENT: 30% OF PURCHASE PRICE (This payment is normally made at contract signing within 30 days maximum of initial holding deposit)

SECOND STAGE PAYMENT: 30% OF PURCHASE PRICE (This payment is normally made upon completion of main structure, roof, concrete areas and pool first stage)

THIRD STAGE PAYMENT: 30% OF PURCHASE PRICE (This payment is normally made upon completion of windows, doors, final finishing, pool and fixtures/fittings etc.)

FINAL PAYMENT: 10% OF PURCHASE PRICE***

(Payable upon final completion & customer inspection of works. Inspection within 30 days of customer being notified as completed.)

How big is the SLHH development?	The development is approx. 40 Rai (16 acres) of Land and in addition 16 Rai (6 acres) of Lakes. Having 32 villas in phase 1			
What are the villa plot sizes?	The villa plot size is from 500 sq.m. to 2,253 sq.m.

When will the villa be completed? What is the kitchen and wardrobe package?	The construction of the villa shall be completed within 10 months from the contract upon receiving the first payment from the Buyer. Each villa comes with :- A walk-in wardrobe for the Master Bedroom. The kitchen comes with high quality cabinets, electrical components. The			
Are there any warranty on the Villa and for how long?	package include the following items : Kitchen cabinet, Hob, Hood, Sink, Tap, Oven, Refrigerator & Microwave. SLHH will provide a warranty period of 10 (Ten) years for the Villa structure i.e. foundation pile, base, beam pile and roof structure from the Handover Date.

Maintenance & Lifestyle	
How much are the maintenance fees and what are the services provided?	 The maintenance fees is to be paid to a maintenance company for maintaining SLHH., payable 6 months in advance. The fees may vary depending on the size of the plot. In general, the maintenance fees for villas is from 5,000 THB per month. (10 THB/ sq.m.) The maintenance fees cover the following services: 24-hour security Electricity and Water usage for common area Gardening to common garden area Up keeping of the Lake Maintenance of internal roads and drains Garbage collection Pest control to private villas and common area If you pay 15 THB/ sq.m. it will cover Garden and Swimming pool services; Swimming pool cleaning and also including chemicals Garden service for your villa.
What is a sinking fund?	The sinking fund is a reserved fund to repair or replace any major equipment and utilities that needs to be done for common area. There is a one-time fee of 30,000 THB when purchasing a villa and a monthly fee of 250 THB to maintain the sinking fund.
What are the cost for Electricity & Water. And How will each villa be charged?	SLHH only charge the Homeowners the same rate for electricity and water as the government charges. All homeowners in SLHH will pay 6 months in advance for their electricity and water bill. It will be deducted according to the meter and Homeowners will be informed on a monthly basis on their usage and account status.

What is the ownership rights when purchasing a villa?	Homeowner will have ownership of the building, the land will be leased from the landowner which is Sanctuario Properties Co, the land lease is for 30 years. It can be renewed 2 times for a total of 90 years. Each 30 years lease contract will be registered at the Land Office.
What contracts do I have to sign?	 When purchasing a villa, there are 3 contracts to be signed. 1. Land Lease contract (English & Thai) 2. Sale & Purchase of Villa contract 3. Maintenance contract
